### PRIVACY DISCLAIMER

We inform you that, following EU Regulation 2016/679 (infra: "Regulation"), your Personal Data will be processed by ANFIA Services Srl with its registered office in Corso Galileo Ferraris, 61 - 10128 Turin, in its capacity as the data controller ("Controller").

The Controller will process your data (art. 4.1 of the Regulations) collected by filling in the form for the following purposes:

- a) **Management of your involvement in the Formula SAE Italy event**  
The legal basis for the processing of personal data is represented by the implementation of a contract to which the person concerned is part of or the carrying out pre-contractual activities undertaken at the request of the person concerned (art. 6.1.b of the Regulation).
- b) **taking of photographs and videos for publication and circulation in the media, via any means of communication and distribution without exception, such as but not limited to social networks, web channels, television, satellite, corporate communications, and other means of dissemination, wherever available today or in the future, including the Internet or other telematic networks.**  
The legal basis for the processing of this data is identified. It refers to the expression of consent by the data subject for processing their data (art. 6.1.a of the Regulation).

Recipients of your personal data

Your Personal Data may be shared with:

- The Data Controller authorises individuals to process personal data after signing a confidentiality agreement (e.g., employees and system administrators, technical staff).
- Companies belonging to the Group, third parties involved in various stages of the organisation and running of the competition, third parties involved in the production of audio-visual material, some of whom act as Data Processors. - Persons, bodies, or authorities to whom it is mandatory to communicate your Data following legal provisions or orders from the authorities.

Regarding the possible transfer of Data to Third Party Countries, the Data Controller informs that the processing will take place according to one of the methods allowed by the law in force. Such as, for example, the consent of the data subject, the implementation of a contract between the data subject and the data controller or the execution of pre-contractual measures adopted upon request of the data subject the conclusion or performance of a contract entered into between the data controller and another individual or legal entity for the benefit of the data subject; the adoption of Standard Clauses approved by the European Commission, the selection of issues adhering to international programs for the free movement of data (e.g. EU-USA Privacy Shield) or operating in countries considered secure by the European Commission. #### Methods of data processing

#### Storage of personal data

Your Personal Data will only be kept for the time necessary for the purposes they are collected, respecting the principle of minimisation referred to in Article 5, paragraph 1, letter c) of the GDPR. In all cases, your Personal Data will be kept for the time necessary to perform the services provided for in the contract. This is without prejudice to further storage available for by the relevant legislation, including in Article 2946 of the Civil Code. More information is available from the Controller.

#### Your privacy rights

You have the right to ask the Data Controller at any time to access your data. You may modify or cancel it or object to its processing, request the limitation of its processing, or request the data concerning you in a structured, user-friendly, and machine-readable format according to art. 20 of the Regulation.

You may revoke at any time, under art. 7 of the Regulation, the consent already given, without prejudice to the lawfulness of the processing carried out before the revocation of consent.
